Role Overview

The Job Holder will work as an Investment Associate in the LCM team to assist on pan-European portfolio purchase transactions (both secured and unsecured). The role will be based in London but may require travel to the Group's overseas offices in Spain, Italy, Germany and Ireland and to client sites throughout these markets and the UK, as well as other markets where we might invest. Fluency in French, Spanish and/or German is required for this role.
