The Job Holder will work as a Portfolio Manager assisting with pan-European portfolio management (secured assets). The role will be based in London but may require travel in the UK and overseas to the Servicer's offices in Ireland, Spain, Italy, Germany, Ireland, Poland, France and Portugal.

Job Content

The job holder will be responsible for the following areas:

- Management of servicing partners doing the workout of secured loans and real estate assets purchased by the fund
- Detailed tracking of each individual asset in the portfolios, including: status, offers received, legal workout, insolvency processes, etc.
- Monitoring the different servicing strategies followed in each portfolio
- Review asset performance data, analyse and draw conclusions, and manage the implications as appropriate
- Gathering portfolio performance information from Servicers
- Reviewing and discussing portfolio performance with Servicers
- Tracking costs and servicing fees linked to each individual portfolio
- Oversee operating partners and property managers in their day-to-day management of the assets, and become involved in key decisions
- Supporting the Head of PM in Quarterly Review Processes with Servicers
- Other operational analytical tasks / projects as directed
- Manage more junior colleagues, share the skills and knowledge, assist in training and mentoring them

The job holder will assist the business in the following areas:

- Data analysis for investment review of portfolios
- Updating cash flow models for acquired portfolios
- Analysis and support material for business development initiatives
- Analysis of portfolio performance
- Assisting in portfolio and transaction structure reporting to third parties
